INSTALLATION NOTES

1. The buyer is responsible for providing trained and experienced installation decision making with technical know-how to apply professional judgment that specifically applies to each individual installation.
2. Be sure to read and understand all available information including but not limited to instructions, warnings, sale terms, and warranties for the vehicle and all system components prior to attempting installation.
3. Disconnect negative battery cable. Drain coolant low enough for removal of upper radiator hose. Disconnect the upper radiator hose at the radiator.
4. Remove fan clutch wire and bracket from engine. Remove OEM belt. Disconnect alternator wires and lay aside. Remove OEM alternator. Remove OEM alternator bracket and bolts. The bolts will not be reused.
5. Install main bracket (1) with bolts (2) and lock washers (3) onto the engine block (make sure to install bolt into bracket hole closest to water pump before installing bracket).
6. Install wire extension (13) to OEM main alternator wire with hardware (15-16) and heat shrink (14). Install OEM main alternator with OEM bolt (7) and bolt (8) onto main bracket (1). Wires will lay on top of main bracket (1). Install the two smooth idler pulley assemblies (4-6) onto main bracket (1) (install in hole closest to water pump). Install clutch pump assembly onto main bracket (1) according to the manufacturers' specifications with provided mounting hardware (9-12). Install wire to alternator.
7. Install belt (23). Reinstall fan wire and OEM wire bracket.
8. Remove factory clamp from radiator hose (this is done by cutting at holes and separate plastic clamp). Install rubber elbow (18) with hose clamps (20) install loosely onto the upper radiator hose quick disconnect. Install steel tube (17) with the expanded end into the rubber elbow (18) and adjust as shown in the photo. Mark and cut the OEM upper radiator hose at the appropriate location so it will slip over the steel tube (17) by approximately 1½". Install hose clamp (19) loosely. Then, push steel tube (17) into the modified OEM upper radiator hose. Adjust hose for best fit and clearance to the clutch. Then, tighten all hose clamps and secure the hose to the fan shroud with loom clamp (21) and bolt (22).
9. Reconnect the upper radiator hose quick disconnect to the radiator if needed. Replace the engine coolant and check for leaks.

CAUTION: Before starting the engine. Check to make certain no wires, hoses, etc. that may have been disturbed during installation do not come in contact with any hot or moving parts. Run the engine and check for proper belt tracking, adjust if necessary.



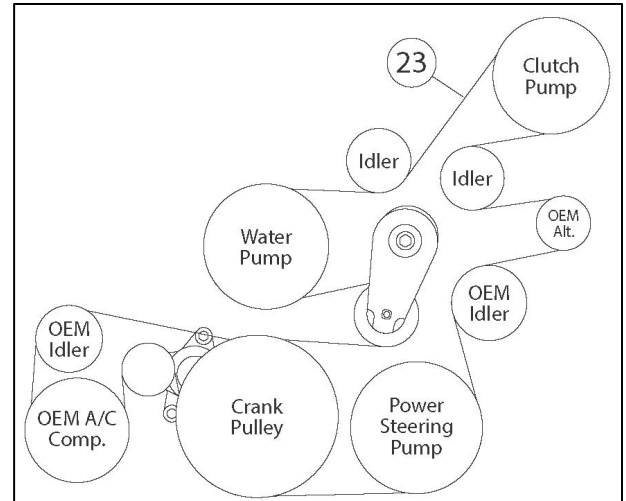
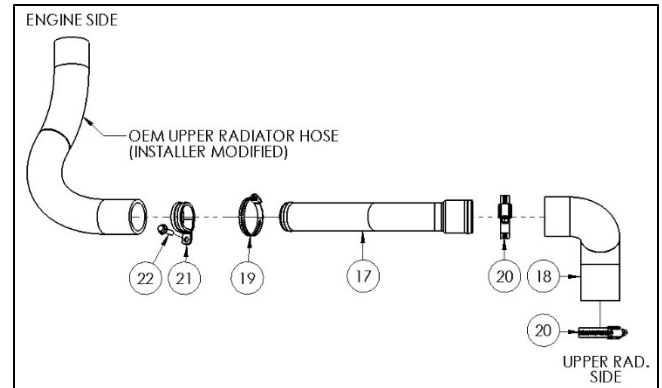
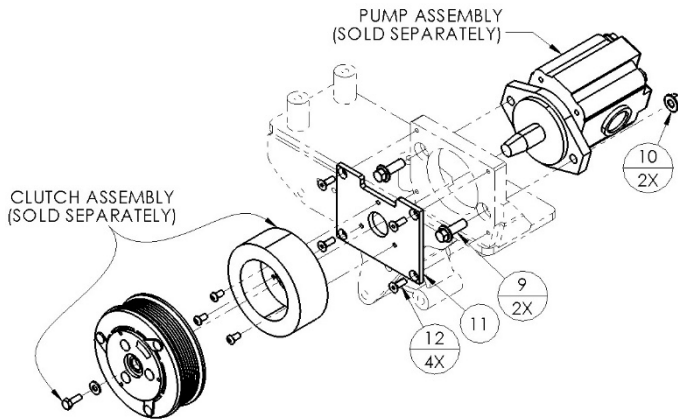
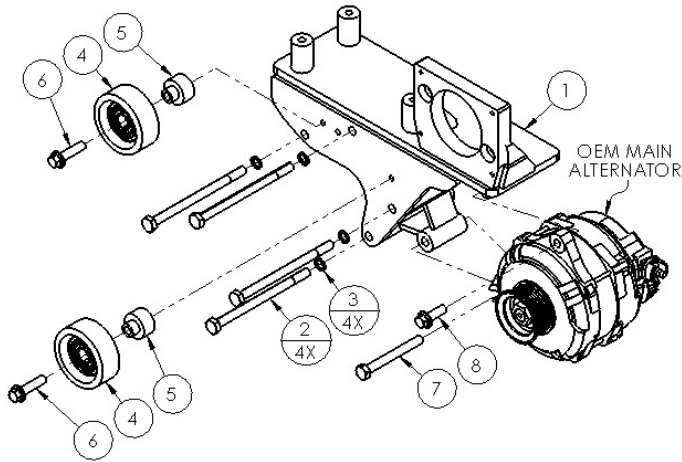

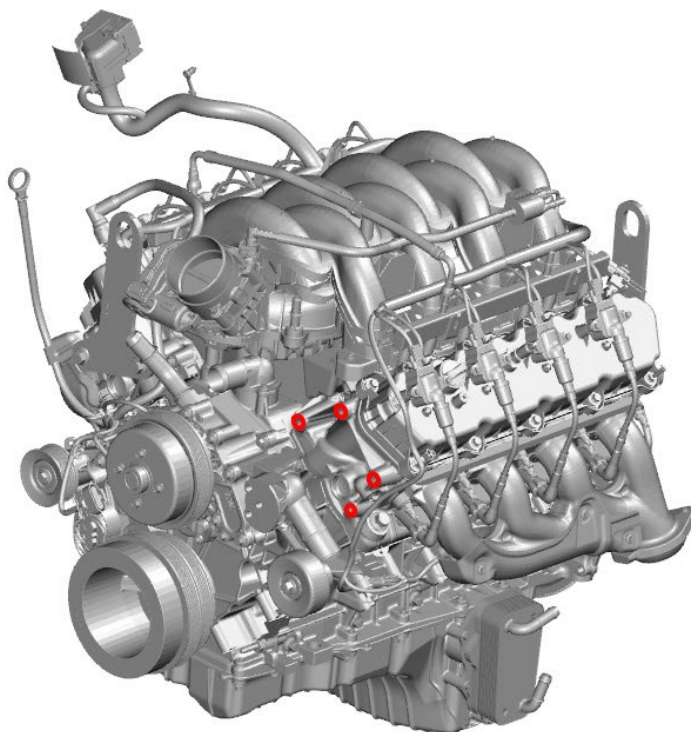
