



CLUTCH PUMPS AND ENGINE MOUNTING KITS

ONE-YEAR WARRANTY

The Muncie F and H Series pump and mounting kits are warranted against any defect in material and workmanship which existed at the time of sale by Muncie, according to the following provisions, subject to the requirements that the Pump and kit must be used only in accordance with catalogue and package instructions, and the pump warranty card must be filled out and returned to Muncie within ten days after the pump is installed.

The Pump and Mounting Kit is warranted for a period of one year from the date of installation. If during the warranty period the Pump or Mounting Kit fails to operate to Muncie's specifications due to a defect in any part in material or workmanship that existed at the time of sale by Muncie, the defective part will be repaired or replaced, at Muncie's election, at no charge, if the defective part is returned to Muncie with transportation prepaid.

Warning. The above warranty shall terminate if any alterations or repairs are made to the Pump or Mounting Kit other than at a Service Center owned by Muncie, or if the Pump or Mounting Kit is used on any equipment other than the equipment upon which it is first installed.

As to any F and H Series pump which is rebuilt and retested at a Service Center owned by Muncie, the period of the above warranty is extended for a period of one additional year from the retest date.

NOTE: Normal maintenance items such as belts, pulleys, tensioners, and bearings are not covered under Muncie's one-year warranty and are limited to the manufacturer's warranty which is approximately 90 days or less.

OTHER WARRANTIES

Chassis manufacturers have their own warranty statement provided to body builders when mounting auxiliary bodies and equipment onto vehicles. These warranty statements should be reviewed and acknowledged to the end user before mounting equipment onto vehicles.

When an Aftermarket Engine Mounted Pump Drive System has been chosen as the source of auxiliary power for truck-mounted equipment, Muncie Power Products offer the following:

Responsibility is placed on the installer for the proper installation of this type of equipment and to inform the end user of potential fan-to-radiator clearance problems, of potential water pump shaft/bearing problems, of difficulty in servicing O.E.M. accessories and belts, and any other potential problems that can be associated with or without the use of this type of equipment. Customer options to reduce the potential risk of problems would be to install from the chassis manufacturer or aftermarket automotive parts warehouse a light-weight, short-profile replacement flex fan or a self-contained, independently-operated electric fan at their discretion.

Muncie Power Products assumes no responsibility for the installation or relating to any of the mentioned or unmentioned problems for the use, misuse or nonuse of these optional Fan Drive Systems.

MUNCIE WILL IN NO EVENT BE LIABLE FOR ANY DIRECT, INDIRECT, SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES WHATSOEVER, AND OUR LIABILITY UNDER NO CIRCUMSTANCES WILL EXCEED THE CONTRACT PRICE FOR THE GOODS FOR WHICH LIABILITY IS CLAIMED.
